Riders added to a route after busing commences for the school year will be billed pro-rata, based on the remaining school days from the first date of ridership. Transportation Fees will be billed to the Student Account.

ROUTE INFO: ISM will contact you with exact pick-up/drop-off times and locations before or during the week of August 19, 2019.

BUS STOP AND PASSENGER INFORMATION: When logistically feasible, particularly in areas close to ISM and areas that have a high concentration of bus riders, door-to-door service is more likely to be offered. In some cases, such as outlying areas that are considerably farther from ISM or from a proposed route, regional locations will be established as an alternative to door-to-door service. Typically, regional bus stops will be a 3-10 minute drive from a bus rider's home. Every effort will be made to keep your child's bus ride as short as possible. Students picked up in the morning farthest from ISM should expect an approximate pick-up time between 6:35-7:00 a.m. Buses will arrive at ISM at approximately 8:00-8:10 a.m. Afternoon buses will depart at 4:25 p.m. on regular school days and at 12:30 p.m. on half days. ROUTE CONDITIONS: From time to time, road conditions due to weather, construction, traffic congestion, and other conditions beyond the control of the bus company or ISM may alter stop times.

ROUTE CHANGES: ISM reserves the right to make changes to pick-up/drop-off times and bus stop locations to accommodate necessary route changes at any time during the school year.

ISM REFUND POLICY: ISM will refund Transportation Fees to you if you cancel your contract for any of the following reasons:

• ISM cancels the bus route;

• ISM's bus route minimum ridership requirements have not been met;

• ISM's bus route has reached maximum capacity;

• ISM has offered you a single regional stop location and ISM receives your notice of termination within 5 days of receipt of notice from ISM. Full refunds will be issued if you cancel your contract for any of the above-listed reasons prior to the first date of ridership. Partial refunds will be issued on a prorata school-day basis for cancellations received after the first date of ridership. **TRANSPORTATION REBATE PROGRAM:** If you cancel your contract for any other reason not listed in the above ISM Refund Policy,

TRANSPORTATION REBATE PROGRAM: If you cancel your contract for any other reason not listed in the above ISM Refund Policy, including but not limited to dropoff/pickup time changes, stop location changes, school enrollment termination, or student's loss of bus privileges due to misconduct, you will be eligible for a refund only if you have opted into the Transportation Rebate Program. The Transportation Rebate Program Fee is \$175 per student, billed to the Student Account September 30, 2019. Rebates will be issued on a prorata school-day basis at a rate of 60% of the Transportation Fee paid.

ACKNOWLEDGEMENT: I agree to make full payment for each student at the rates described above. I have read, understand, and agree to abide by ISM's policies for bus rider and parental/guardian supervision of bus riders. I understand bus riders must abide by ISM and Mainline Transportation, Inc school bus rules and policies, and that any behavior in violation of such rules or policies will result in disciplinary action and possible loss of bus privileges. I understand ISM does not own or operate the buses that will be used to transport my student(s), nor employ the bus drivers, and that ISM has contracted with Mainline Transportation, Inc., a third party bus charter company to provide transportation to and from ISM. I understand traveling by bus involves risks and dangers of serious bodily injury and death. I acknowledge and assume these risks and on behalf of my child(ren). I agree not to hold ISM, its parent or affiliates, or their directors, officers, managers, or employees (collectively the "School") liable for any claims, actions, damages, injuries, losses, costs, or expenses ("harm") that may arise in connection with ISM's transportation program, excluding Harm resulting from School conduct that constitutes greater-than-ordinary negligence. I understand this contract contains the entire agreement between ISM and me relating to bus transportation, and supersedes any and all prior agreements, understandings, representations, and statements between ISM and me, whether verbal or written. I am signing this contract based solely on the representations and warranties contained in this contract and not based on any promises, representations, and/or warranties not found in this contract. No modification, waiver, amendment, or change of this agreement shall be valid unless the same is in a signed writing. I understand this is a binding agreement and by signing below I agree to all terms and conditions above.
